**Details:**

CMB NV has announced the intention to make a mandatory public takeover bid on the remaining shares in Euronav that are not already owned by CMB or its affiliates at a price of USD 18.43 (the Offer). The Offer is contingent upon the success of a share purchase agreement, merger control approvals and the approval by the Euronav shareholders' meeting of the conditionality of the vessel sale on the completion of the share purchase agreement.

**Adjustments:**

Provided that the Offer becomes effective, the contracts shall be de-listed with immediate effect and will be settled using the Fair Value method. In determining the Fair Value settlement prices, the following will apply:

**Options:**

- **Fair Value Volatilities:** For each individual series, Euronext will use the settlement volatility, which has been used for the calculation of the Daily Settlement Prices by Euronext Pricer, as shown in the Attachment to this Notice. In accordance with the Corporate Actions Policy, the Fair Value volatilities are determined from the Daily Settlement Prices of each respective contract series over the ten trading days preceding the announcement of the Offer, being the period from 25 September 2023 to 6 October 2023 inclusive.
- **Dividends:** The average dividend forecasts used for the calculation of daily Settlement Prices by Euronext Pricer, collected over a ten-trading day period (shown in the attachment to this notice).
- **Interest Rates:** Interest rates as used by Euronext Pricer on the effective date.
