INTRODUCTION OF OPTION SERIES WITH AN INITIAL LIFETIME OF 18 AND 24 MONTHS FOR 7 INDIVIDUAL EQUITY OPTION CLASSES AND INTRODUCING OPTION SERIES WITH AN INITIAL LIFETIME OF 36 MONTHS FOR THE OPTION CLASS ON ARCELORMITTAL.

## **Executive Summary**

Euronext Amsterdam will add option series with initial lifetimes of 18 and 24 months for 7 Individual Equity Option classes listed on the Amsterdam derivatives market.

For the option class on ArcelorMittal the December-2016 expiry month will initially be introduced. These new maturities will be available for trading as from Monday 23 December 2013.

## 1. Introduction

- 1.1 Euronext Amsterdam hereby announces that longer dated option series for 7 Individual Equity Option classes (IEOs) on the Amsterdam derivatives market will be introduced as from Monday 23 December 2013. The introduction will result in adding maturities with an initial lifetime of 18 and 24 months, according to the Half-yearly cycle.
- 1.2 Additionally, Euronext Amsterdam will also make available for trading the December-2016 maturity (36 months) for ArcelorMittal (MT). Euronext Amsterdam will closely monitor the development of this new maturity and decide at a later stage whether or not a maturity with an initial lifetime of 36 months will become a permanent change to the product specifications for the option class on MT.

## 2. Individual Equity Option classes

- 2.1 The 7 IEOs for which the maturities with initial lifetimes of 18 and 24 months will be introduced are:
  - AIR FRANCE-KLM (AFA)
  - KONINKLIJKE BAM GROEP NV (BAM)
  - FUGRO NV (FUR)
  - POSTNL NV (PNL)
  - RANDSTAD HOLDING NV (RND)
  - TNT EXPRESS NV (TNE)
  - USG PEOPLE NV (USG)

The **Euronext Derivatives Markets** comprise the markets for derivatives operated by Euronext Amsterdam, Euronext Brussels, Euronext Lisbon, Euronext Paris and LIFFE Administration and Management, referred to respectively as the Amsterdam, Brussels, Lisbon, Paris and London markets. Euronext is part of the NYSE Euronext group.

2.2 On Monday 23 December 2013 the December-2014; the June-2015 and the December-2015 expiry months will become available for trading for these 7 IEOs. The new expiry months will be available for trading next to the already listed January-2014, February-2014, March-2014, June-2014 and September-2014 expiry months.

As from Monday 23 December 2013 the initial lifecycle for this 7 IEOs will be as follows:

2.3 On Monday 23 December 2013 the following months will be available for trading for ArcelorMittal (MT): January-2014, February-2014, March-2014, June-2014, September-2014, December 2014, June-2015, December-2015 and December-2016.
