## **Executive Summary**

- 2. This Notice confirms the appointment of Susquehanna International Securities Limited as Primary Market Maker for the option classes set out in the Attachment to this Notice. Such appointment is subject to standard contractual terms.
- 3. The Liquidity Provider Programme will start from 11 July 2014 and will remain in place until the close of business on 30 October 2015.
