#### INTRODUCTION OF ADDITIONAL PAN-EUROPEAN SINGLE STOCK FUTURES IN NON-EUR CURRENCIES

#### **Executive Summary**

Euronext intends to launch a range of Single Stock Futures contracts on stocks listed at Oslo Stock Exchange, SIX Swiss Exchange, NASDAQ OMX Stockholm, NASDAQ OMX Copenhagen and London Stock Exchange. The introduction of these contracts is scheduled in June and July 2015.

#### 1. Introduction

1.1 Euronext intends to launch additional Single Stock Futures (SSFs) on the Amsterdam Derivatives Market. These SSFs are futures on stocks listed at Oslo Stock Exchange, SIX Swiss Exchange, NASDAQ OMX Stockholm, NASDAQ OMX Copenhagen and London Stock Exchange. The trading currency of these SSFs is NOK, CHF, SEK, DKK and GBX (pence) respectively.

### 2. Single Stock Futures

- 2.1 Each SSF has a contract size of 100 shares (for UK shares 1,000 shares) and the tick size is NOK/CHF/SEK/DKK 0.0001 and GBX 0.01. Open positions remaining after the last day of trading will lead to cash settlement. The full contract specifications are set out in attachment 1. The list of underlying values and the planned launch date is shown in attachment 2
- 2.2 The SSFs are not available for trading on days that the domestic cash market is closed. Attachment 3 shows the days that the SSFs will be closed for trading in 2015.

## 3. Member onboarding and post-trade readiness

To confirm their interest in trading the SSFs listed in NOK, CHF, SEK, DKK and/or GBX, current Euronext Trading Members are invited to return the completed 'Euronext Derivatives markets – Request for extension of trading activity' <u>form</u>, also available via this <u>link</u>, to <u>EuronextMembership@euronext.com</u>.

To prepare for the launch and carry out tests before going live, Members are asked to contact their Clearing Member to confirm the post-trading set up (clearing and settlement) in NOK, CHF, SEK, DKK and/or GBX. The Clearing Members confirm with LCH.Clearnet SA the requirements for clearing and settlement in NOK, CHF, SEK, DKK and/or GBX business and ensure the readiness of the post-trading set up. Then, the trading rights are open on the EUA trading environment to carry out tests, from order entry to clearing/settlement with the Clearing Member.

The Euronext Markets comprise the markets operated by Euronext Amsterdam, Euronext Brussels, Euronext Lisbon, Euronext Paris and Euronext London, referred to respectively as the Amsterdam, Brussels, Lisbon, Paris and London markets, as relevant. Euronext refers to Euronext N.V. and its affiliates.

## 4. Liquidity Provider information

- 4.1 For the full Liquidity Provider Programme specifications including obligations and benefits please refer to the Liquidity Provider Programme Info-Flash which is available on the <u>Euronext website</u>.
- 4.2 All Members are eligible to apply for a Liquidity Provider status.
- 4.3 Current Liquidity Providers in SSFs on the Amsterdam market wishing to apply for a Liquidity Provider role should complete the Liquidity Provider **Update Form**.
- 4.4 Members who are currently not a Liquidity Provider in SSFs on the Amsterdam market and wishing to apply for a Liquidity Provider role should complete the Liquidity Provider **Registration Form** and inform their Clearing Member to get the extension of their capacity in Trading and Clearing systems as LP.
- 4.5 Both the Update and Registration Forms are available on the <u>Euronext website</u>.
- 4.6 Customers who wish to become a Liquidity Provider for the additional pan-European Single Stock Futures contracts are required to contact the Customer Technical Support Group (CTSG) on <a href="mailto:ctsg@euronext.com">ctsg@euronext.com</a> in order to complete a conformance test on the EUA platform. Other customers are not required to complete a conformance test.
