**Details:** Atlantia S.p.A (“Atlantia”) announced a voluntary public tender offer on the entire issued shares of Abertis Infraestructuras SA (“Abertis”), whereby shareholders will receive €16.50 in cash for each Abertis share tendered (“the Offer”).

**Adjustments:** Provided that the Offer becomes effective, the contracts shall be de-listed with immediate effect and will be settled using the Fair Value method. In determining the Fair Value settlement prices, the following will apply:
