HoldCO II (controlled by Xavier Niel) is launching a simplified public tender offer for all Iliad shares with an offer price of EUR 182 per share ("the Offer").

**Adjustments:**

Provided that the Offer becomes effective, the contracts shall be delisted with immediate effect and will be settled using the Fair Value method. In determining the Fair Value settlement prices, the following will apply:

### Options:

- **Fair Value Volatilities:** For each individual series, we will use the settlement volatility, which has been used for the calculation of the Daily Settlement Prices by Euronext Pricer, as shown in the Attachment to this Notice. In accordance with the Corporate Actions Policy, the Fair Value volatilities are determined from the Daily Settlement Prices of each respective contract series over the ten trading days preceding the announcement of the Offer, being the period from 16 July 2021 to 29 July 2021 inclusive.
- **Dividends:** No relevant dividends forecasts in the Euronext Pricer are used for the calculation of daily Settlement Prices by Euronext Pricer, collected over a ten-trading day period.
- **Interest Rates:** Interest rates as used by Euronext Pricer on the effective date.
