The offer of the France State for all shares of Electricite De France has been declared effective.

For the avoidance of doubt, since a ruling from the Paris Court of Appeal regarding the compliance decision from the AMF on the public offer is still pending, once Euronext has settled the contracts using the published fair value settlement prices, there will be no revision to those prices, no matter the outcome of the ruling.
