### TRADING TICK SIZE CHANGE FOR KONINKLIJKE DSM NV WEEKLY OPTIONS

#### **Executive Summary**

This Notice informs Members of a COB trading tick size change for weekly individual equity options on Koninklijke DSM NV shares per 15 November 2021.

#### 1. Introduction

1.1 Euronext will change the COB trading tick size for weekly individual equity options on Koninklijke DSM NV shares in the Amsterdam Derivatives Market per 15 November 2021. The COB trading tick size of the weekly options will be aligned with the COB trading tick size of the corresponding monthly contract on Koninklijke DSM NV shares.
