Details: Norsk Hydro announced a special dividend of NOK 1.45.

Adjustments: After the close of business on 20 September 2022 the following

contract adjustments will be made:

- Ratio Method
- Cum Event Price: Official closing price of Norsk Hydro on Oslo Børs on 20 September 2022.
- Lot Size: The lot size will be divided by the Ratio. The adjusted lot size will be specified in the Final Notice.
- Ratio = (Cum Event Price NOK 1.45) (Cum Event Price)

Options:

- **Exercise Prices:** The exercise prices will be multiplied by the Ratio. The adjusted exercise prices will be specified in the Final Notices.
- **Equalisation payment:** The rounding difference of the adjusted lot size will be neutralised by means of an equalisation payment.

Futures:

- Variation Margin: Daily Settlement Prices for 20 September 2022 shall be multiplied by the Ratio to generate reference prices for the purpose of variation margin calculations at the close of business on the Effective Date.
- **Single Stock Dividend Futures:** Ordinary dividends with an exdate on or before the Effective Date shall be multiplied by the Ratio for the purpose of determining the EDSP at the end of the lifetime of the Dec22 maturity in contract NH8.
