### EXTENSION LIFETIME WEEKLY OPTIONS

#### Executive Summary

The lifetime of weekly options will be extended to two weeks as from Friday 25 October 2013.

1. Currently weekly options are available for trading as from the Friday one week prior to expiry. As from 25 October 2013 weekly options will be available for trading as from the Friday two weeks prior to expiry. The initial lifetime of weekly options is then extended to two weeks.
2. The extended lifetime will start on Friday 25 October 2013 with the introduction of the AEX-index® weekly option class AX2, and the equity weekly option classes 2AG, 2IN, 2KP, 2MT, 2PH and 2RD.
3. On 25 October the following will be applicable:
  - The AX4, 4AG, 4IN, 4KP, 4MT, 4PH and 4RD weekly options expire.
  - The AX1, 1AG, 1IN, 1KP, 1MT, 1PH and 1RD weekly options are introduced. These are the last weekly options with an initial lifetime of one week.
  - The AX2, 2AG, 2IN, 2KP, 2MT, 2PH and 2RD weekly options are introduced. These are the first weekly options with an initial lifetime of two weeks.
4. The introduction calendar in the attachment shows the introduction schedule of weekly options for the remainder of the year.
