Details: Safran and Zodiac Aerospace announced that they have entered into exclusive negotiations for an acquisition of Zodiac Aerospace by Safran. Safran would launch a tender offer on Zodiac Aerospace's shares at €29.47 per share ("the Offer").

Adjustments: Provided that the Offer becomes effective, the contracts shall be de-listed with immediate effect and will be settled using the Fair Value method. In determining the Fair Value settlement prices, the following will apply:

Futures:
