### FREEZE ETF OPTIONS

#### Executive Summary

This notice informs Members about the freeze of ETF option classes<sup>1</sup>. No new expiry months will be introduced for six ETF option classes and no new expiries will be introduced for all weekly ETF option classes.

#### 1. ETF options

Euronext will stop the introduction of new expiry months for six ETF option classes. The result will be that following the June-2020 expiry these 6 ETF option classes will no longer exist. The freeze will be applicable for the following six ETF option classes:
