- **Single Stock Futures:** As there is no open interest in the UG6 and UG7 contract no adjustment have been made to the Lot size of these contracts.

**Order cancellation:** All outstanding orders for the contracts will be cancelled automatically after the end of the trading session today. The priority of these orders will then be lost. New orders can be submitted as from 15 March 2021.
