Options

- Equalisation payment/Lot size: For the RND contract the Ratio Method results in a Lot size that is between 100 and 105, so for this contract no Oclass will be introduced. The Lot Size will be rounded to 100 and an equalisation payment will be made to neutralise the effect observed due to rounding of the Lot Size. For the RNO contract the lot size will stay unchanged at 1 lot and the rounding will be neutralised by an equalisation payment.
- **Exercise Prices:** The exercise prices have been multiplied by the Ratio, as shown in the attachment to this Notice.

Futures

- **Single Stock Futures:** Given that there is no open interest, no adjustments have been made to the contracts.
- Single Stock Dividend Futures: Ordinary dividends with an ex-date on or before the Effective Date shall be multiplied by the Ratio, for the purpose of determining the EDSP at the end of the life time of the Dec19 maturity in contract RA8. Given that there is no open interest, no further adjustments have been made to the contracts.
