Details: Electricite de France has announced a rights issue, whereby

shareholders are entitled to purchase 2 new shares for every 13 existing shares held, at a subscription price of €6.35 per new share.

Adjustments: After the close of business on the 18 March 2022, the following contract

adjustments will be made, insofar that the right has positive value:

Ratio Method.

■ **Cum Event Price:** Official closing price of Electricite de France shares on Euronext Paris of 18 March 2022.

■ Lot Size: The lot size will be divided by the Ratio. The adjusted lot size will be specified in the Final Notice.

■ Value of right = $\frac{\text{(Cum Event Price - } €6.35)}{\text{(13/2 + 1)}}$

■ Ratio = (Cum Event Price - Value of right) (Cum Event Price)

Options:

- **Exercise Prices:** The exercise prices will be multiplied by the Ratio. The adjusted exercise prices will be specified in the Final Notices.
- **Equalisation payment:** The rounding difference of the adjusted lot size will be neutralised by means of an equalisation payment.

- **Variation Margin:** Daily Settlement Prices for 18 March 2022 shall be multiplied by the Ratio to generate reference prices for the purpose of variation margin calculations, at the close of business on 21 March 2022.
- **Single Stock Dividend Futures:** Ordinary dividends with an exdate on or before the Effective date shall be multiplied by the Ratio, for the purpose of determining the EDSP at the end of the lifetime of the **JUN22**, **SEP22** and **DEC22** maturity in contract DF8.

Orders:

All outstanding orders will be cancelled automatically after the end of the trading session on the day before the effective date. The priority of these orders will then be lost. New orders can be submitted as from the effective date.

It requires the immediate attention of Members' staff involved with the trading and settlement of equity products on these markets.
