- **Single Stock Dividend Futures:** Ordinary dividends with an ex-date on or before the Effective date shall be multiplied by the Ratio, for the purpose of determining the EDSP at the end of the lifetime of the **Sep21** and **Dec21** maturity in contract VI8. As there is no open interest in the SSDF no further adjustments have been made to the contract.
