Details: Veolia has announced that they intend to make a public takeover bid for the entire share capital of Suez at a price of EUR 18 per share (cum dividend) as soon as the Board of Directors of Suez issues an opinion in favour of this proposal.

Adjustments: Provided that the Offer becomes effective, the contracts shall be de-listed with immediate effect and will be settled using the Fair Value method. In determining the Fair Value settlement prices, the following will apply:

Options:

- **Fair Value Volatilities:** For each individual series, we will use the settlement volatility, which has been used for the calculation of the Daily Settlement Prices by Euronext Pricer, as shown in the Attachment to this Notice. In accordance with the Corporate Actions Policy, the Fair Value volatilities are determined from the Daily Settlement Prices of each respective contract series over the ten trading days preceding the announcement of the Offer, being the period from 20 October 2020 to 02 November 2020 inclusive.
