### DELISTING OF SSF AND SSDF CONTRACTS ON ITALIAN UNDERLYINGS

#### Executive Summary

This Notice informs Members that the remaining SSF and SSDF contracts on Italian underlyings will be delisted from the Derivatives Market of Euronext Amsterdam.

In preparation for the migration of the Borsa Italiana derivatives market to Optiq in March 2024, the remaining Single Stock Futures (SSF) and Single Stock Dividend Futures (SSDF) contracts on Italian underlyings that are listed on the Derivatives Market of Euronext Amsterdam will be delisted as from 9 October 2023. These contracts will be suspended as of 5 October 2023.
