### TRADING HOURS EURONEXT DERIVATIVES MARKETS: 24 DECEMBER 2018 TO 4 JANUARY 2019

#### Executive Summary

This notice provides information regarding the trading arrangements for the Euronext Derivatives Markets for the period of 24 December 2018 to 4 January 2019.

The trading hours for the Euronext Amsterdam, Brussels, Lisbon and Paris Derivatives Markets during the period of Monday 24 December 2018 to Friday 4 January 2019 are summarised in Appendix 1, below.

The AtomX derivatives trade capture service will follow the half-day trading closing times in line with the Large-in-Scale facility.

The introduction of daily AEX-Index® options will differ from the normal introduction and expiry cycles. On Monday 24 December and Monday 31 December 2018 no AEX-Index® daily option will expire. The first trading day of the 27 December 2018 daily AEX-Index® option will be on 21 December. The first trading day of the 2 January 2019 daily AEX-Index® option will be on 28 December 2018.
