### INTRODUCTION OF ADDITIONAL EXPIRY MONTHS FOR SEVERAL OPTION CLASSES

#### Executive Summary

This notice informs Members that Euronext will add options series with an initial lifetime of 9 months to the Individual Equity Option classes on Euronav NV, Fagron and Argenx. Options series with an initial lifetime of 18 months will be added to the Individual Equity Option classes on Galapagos NV, Solvay, KBC Group NV, UCB, Agfa-Gevaert and Colruyt NV.

1. Euronext announces that option series with an initial lifetime of 18 months will be introduced for Galapagos NV (option trading symbol: GLS), Solvay (SOL), KBC Group NV (KBC), UCB (UCB), Agfa-Gevaert (AGE) and Colruyt NV (COL) on the Brussels derivatives market as from 23 March 2020.
2. On Monday 23 March 2020 the **June-2021** expiry month will be available for trading next to the already listed April-2020, May-2020, June-2020, September-2020, December-2020 and March-2021 expiry months.
