Variation Margin: Daily Settlement Prices of 17 April 2020 shall be multiplied by the Ratio to generate reference prices for the purpose of variation margin calculations at the close of business on 20 April 2020.

New contract: In the event that the Ratio results in an adjusted Lot Size exceeding the standard Lot Size, a new contract will be introduced.

Active orders: All outstanding orders for contract FZ6 will be cancelled automatically after the

end of the trading session on 17 April 2020. The priority of these orders will then be lost. New orders in contract **FZ6** can be submitted as from 20 April 2020.
