Royal Dutch has announced a simplification of their company share structure by establishing a single line of shares to eliminate the complexity of Shell's A/B share structure. Royal Dutch Shell will also change the name to Shell plc. The name change is expected in the week of 24 January 2022.

**Adjustments:**

The contracts shall be re-designated as contracts based on the Shell Plc single line shares and will trade in Euro under ISIN code GB00BP6MXD84 listed on Euronext Amsterdam.
