### EXTENSION OF LIFETIME OF WEEKLY OPTIONS

#### Executive Summary

This Notice informs Members of the extension of the lifetime of French weekly options from two to three weeks as of **23 December 2022**.

At this moment, all Euronext weekly options are made available for trading two weeks before expiration. Euronext is pleased to inform Members that as of 23 December 2022, weekly options will be tradable **three** weeks before expiration.

This change, which is being introduced at customer request and which will provide members with more flexible trading possibilities, will be introduced for the following contracts:
