### **Euronext Eurozone 300 Index**

The index targets the sectorial repartition of the Reference Index Universe, composed of the 300 biggest blue chips in the Eurozone: the Euronext Eurozone 300 index, on which we apply 4 exclusion filters (negative screening):

- The 20% lowest-ranking companies in terms of Social assessment
- The 20% lowest-ranking companies in terms of Governance assessment
- The companies facing critical controversies with regards to the United Nations Global Compact (UNGC)
- The companies involved in coal, tobacco or weapons (landmines and cluster munitions)

## **Sectorial Repartition**

Then, a selection of the 80 most virtuous companies (best in class) in energy transition is made in their respective sectors (ICB). This enables a diversified index while reducing the climate impact.


## **Social Criteria**

- Employee engagement
- Responsible reorganisations
- Career management

- Salary, health and safety systems
- Non-discrimination
- Child and forced labour
- Fundamental labour rights
- Product safety





## Corporate Governance Criteria

Assessment of a company's capacity to manage risks and opportunities linked to its responsabilities in terms of corporate governance and business ethics.

### Several criteria can be analysed:

- Independance of the board of directors
- Audit and internal controls
- Shareholders' rights
- Executives' remuneration
- Anti-corruption measures
- Anti-competition and responsible lobbying politics
