■ Ratio = (Cum Event Price - SEK 9.50) (Cum Event Price)

Futures:

- Variation Margin: Daily Settlement Prices for 29 June 2021 shall be multiplied by the Ratio to generate reference prices for the purpose of variation margin calculations at the close of business on 30 June 2021.
- New contract: In such case that the Ratio results in an adjusted lot size exceeding the standard lot size for contracts VV6 (100) and VV8 (10,000), new contracts (O-class) will be introduced. Contracts VV6 and VV8 will keep the standard lot size.

Single Stock Dividend Futures: Ordinary dividends with an ex-date on or before the Effective Date shall be multiplied by the Ratio for the purpose of determining the EDSP at the end of the lifetime of the Dec21 maturity in contract VV8.

Outstanding orders: All outstanding orders for contracts VV6 and VV8 will be cancelled automatically after the end of the trading session on 29 June 2021. The priority of these orders will then be lost. New orders can be submitted as from 30 June 2021.
