Ratio: 0.25000000

Lot Size: No adjustment shall be made to the lot size.

Positions: All open positions shall be multiplied by 4.

Options:

Exercise Prices: The exercise prices will be multiplied by the Ratio. The adjusted exercise prices will be specified in the Final Notice.

Futures:

- Variation Margin: Daily Settlement Prices for 15 June 2022 shall be multiplied by the Ratio to generate reference prices for the purpose of variation margin calculations at the close of business 16 June 2022.
- **Single Stock Dividend Futures:** Ordinary dividends with an exdate on or before the Effective date shall be multiplied by the Ratio, for the purpose of determining the EDSP at the end of the lifetime of the **Jun22**, **Sep22** and **Dec22** maturities in contract ML8.
