Ratio Method

■ **Cum Event Price:** Official closing price of A.P. Moller-Maersk on Nasdaq OMX Copenhagen on 28 March 2023.

■ Lot Size: The lot size will be divided by the Ratio. The adjusted lot size will be specified in the Final Notice.

■ Ratio = (Cum Event Price - DKK 2000 - DKK 2300) (Cum Event Price - DKK 2000)

# **Options:**

- **Exercise Prices:** The exercise prices will be multiplied by the Ratio. The adjusted exercise prices will be specified in the Final Notice.
- **Equalisation payment:** The rounding difference of the adjusted lot size will be neutralised by means of an equalisation payment.

## **Futures:**

- Variation Margin: Daily Settlement Prices for 28 March 2023 shall be multiplied by the Ratio to generate reference prices for the purpose of variation margin calculations at the close of business on the effective date.
- Single Stock Dividend Futures: Ordinary dividends with an exdate on or before the Effective Date shall be multiplied by the Ratio for the purpose of determining the EDSP at the end of the lifetime of the Dec23 maturity in contract MX8.
