- **Lot Size:** 103 shares per lot, therefore the RTL option class will be converted in to the RTL option class (lot size 100) and the O-class contract RTO (lot size 3). The lot size will remain unchanged for the O-class contract RLO. The rounding difference will be neutralised by means of an equalisation payment, the equalisation amounts per series shall be communicated in an additional Corporate Action Notice.
- **Exercise Prices:** The exercise prices will be multiplied by the ratio as shown in the Attachment to this Notice.

**Further Series:** No new series will be introduced in the O-class contract RTO.

**Trading Fees:** Trading fees RTO:

- Trading fees for Broker client account will be reduced to €0.00 for closing transactions, as of 1 September 2014 up to and including 19 December 2014.
- Trading fees for Liquidity Providers will be reduced to €0.00, for both opening and closing transactions, as of 1 September 2014 until the end of the lifetime of the O-class RTO. Prof transactions of Liquidity Providers are charged the Member own account fee.
