**TRADING ARRANGEMENTS FROM 14 MARCH 2011 TO 25 MARCH 2011 INCLUSIVE****AEX<sup>®</sup> INDEX FUTURE CONTRACT (FTI)****Executive Summary**

Notice 2011-004 informed members of changes to trading arrangements for the AEX<sup>®</sup> Index Future Contract and the BEL20 Index Future Contract between 14 March 2011 and 27 March 2011 inclusive. This notice is to correct the information regarding the BEL20 Index Future contract.

***This notice replaces notice 2011-004*****1. Introduction**

1.1 Members will be aware that Daylight Saving Time (“DST”) in the United States commences on 13 March 2011 and ends on 6 November 2011, whereas Central European Summer Time (“CEST”) do not begin until 27 March 2011 and end on 30 October 2011. This Notice informs members of changes to the trading arrangements for certain Exchange Contracts as a result of these differences.

**2. AEX<sup>®</sup> Index Futures Contract**

2.1 For the period of Monday 14 March 2011 to Friday 25 March 2011 inclusive, the Exchange has determined to amend the trading hours for the AEX<sup>®</sup> Index Futures Contract such that these Contracts shall close at 21:00 hours (Amsterdam time).

2.2 Daily settlement prices for AEX<sup>®</sup> Index Futures Contract shall continue to be established at the usual time. Full details of the LIFFE CONNECT<sup>®</sup> session times for this Contract during the relevant period are contained in the Attachment to this Notice.

**3. Normal Session Times**

3.1 The Contract shall revert to its normal session times on and from Monday 28 March 2011.

**4. BEL20 Index Future Contract**

4.1 The trading times of the BEL20 Index Future contract are not impacted by this measurement.
