### INTRODUCTION OF OPTIONS AND FUTURES ON THE GBP/EUR AND GBP/USD CURRENCY PAIRS

#### Executive Summary

NYSE Euronext will launch options and futures on the GBP/EUR and GBP/USD currency pairs on 16 September 2013. Further details are provided below.

#### 1. Introduction

NYSE Euronext will launch options and futures on the GBP/EUR and GBP/USD currency pairs on 16 September 2013 on the Amsterdam derivatives market.

#### 2. GBP/EUR and GBP/USD options

The underlying value of the GBP/EUR options (trading symbol: PEX) is GBP 10,000; exercise prices and premiums are in Euros. The underlying value of the GBP/USD options (trading symbol: PDX) is GBP 10,000; exercise prices and premiums are in US Dollars (see the attachment for contract specifications).

#### 3. GBP/EUR and GBP/USD futures

The underlying value of the GBP/EUR futures (trading symbol: FPE) is GBP 10,000; prices are quoted in Euros. The underlying value of the GBP/USD futures (trading symbol: FPD) is GBP 10,000; prices are quoted in US Dollars (see the attachment for contract specifications).
