### EXTENSION MATURITIES FOR ARKEMA EQUITY OPTIONS

#### Executive Summary

This notice informs Members of the listing of additional short term maturities for Arkema equity options.

1. Euronext has decided to extend the available maturities of Arkema equity options (option trading symbol: AK1) with short term expiry months. Instead of listing the 4 nearest quarterly maturities, the following maturities will be listed: 3 monthly and the following 3 quarterly maturities. The change will be effective as from 20 March 2017.

2. For the new maturity group, the following maturities will be available:

3. On 20 March 2017 for the Arkema equity options the following expiry months will become available for trading, next to the already listed expiry months: Apr-2017, May-2017 and Mar-2018.
