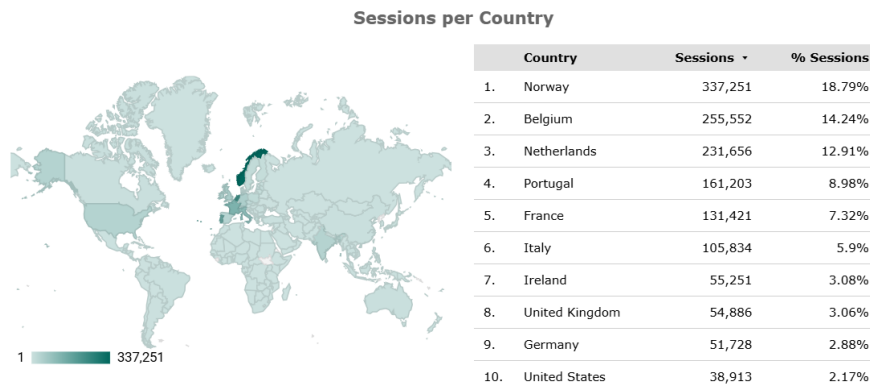

Website sessions per country*



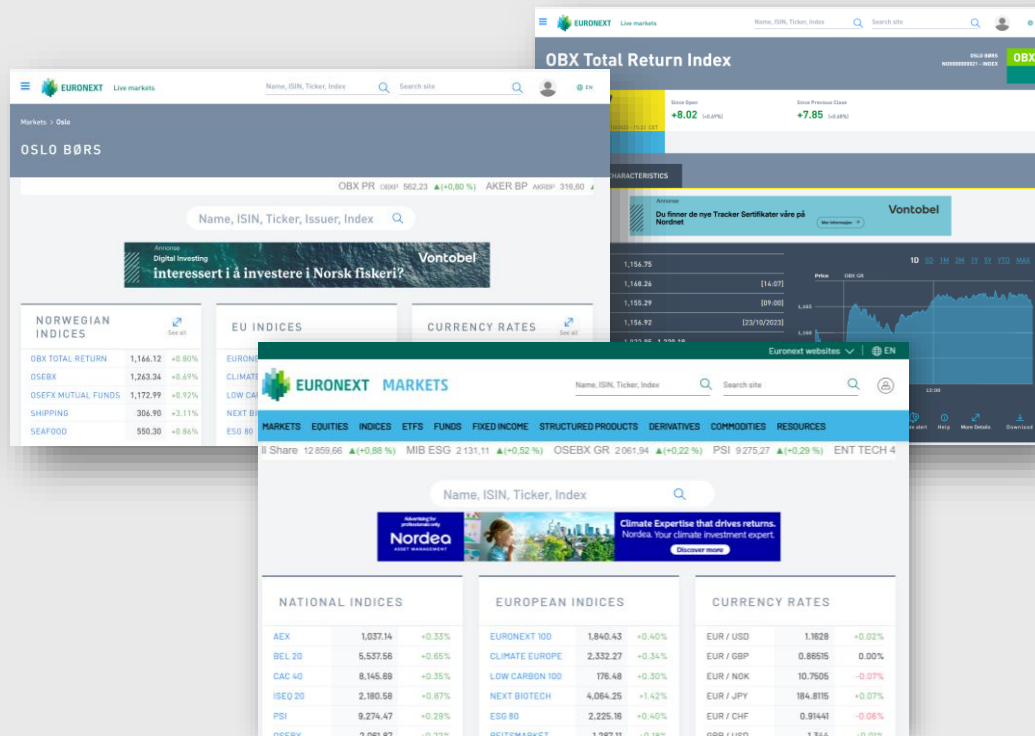




