### Executive Summary

This Notice provides information regarding the trading arrangements for the period of 24 December 2015 to 4 January 2016, and should be read in conjunction with [Info-Flash 150917: Changes to the 2015 Holiday Calendar and Early Closing Dates](#).

The trading hours of the Amsterdam, Brussels, Lisbon and Paris Derivatives Markets during the period of Thursday 24 December 2015 to Monday 4 January 2016, inclusive, can be summarised as described in Appendix 1 of this Notice.

The AtomX derivatives trade capture service will follow the half-day trading closing times for each related contract.

As noted in Appendix 1, as a result of the public holidays and half trading days during this period, the days of introduction and the last trading days of the Weekly Options on Individual Shares, of the AEX-Index<sup>®</sup> Daily and Weekly Options, and of the AEX-Index<sup>®</sup> and CAC40<sup>®</sup> Index Weekly Futures may differ from the normal introduction and expiry cycles.
