**Futures:**

- **Variation Margin:** Daily Settlement Prices of the UG8 contract of 16 April 2021 shall be multiplied by the Ratio to generate reference prices for the purpose of variation margin calculations at the close of business of 19 April 2021.

- **Single Stock Dividend Futures:** Ordinary dividends with an ex-date on or before 16 April 2021 shall be multiplied by the Ratio, for the purpose of determining the EDSP at the end of the lifetime of the **2021** maturities in contract UG8.
- **Single Stock Futures:** As there is no open interest in the UG6 and UG7 contract no adjustment have been made to the Lot size of these contracts.

**Outstanding orders:** All outstanding orders for the contracts will be cancelled automatically after the end of the trading session of 16 April 2021. The priority of these orders will then be lost. New orders for can be submitted as from 19 April 2021.
