- **Ratio:** 0.90909091
- **Lot Size:** The lot size has been divided by the ratio, as shown in the attachment to the notice.

- **Exercise Prices:** The exercise prices have been multiplied by the ratio, as shown in the attachment to the notice.
- **Equalisation payment:** The rounding difference of the adjusted lot size will be neutralised by means of an equalisation payment. The equalisation payment amounts per series shall be communicated in an additional Corporate Action Notice.

**Futures:**

- **Variation Margin:** Daily Settlement Prices for 03 June 2022 shall be multiplied by the Ratio to generate reference prices for the purpose of variation margin calculations at the close of business on 06 June 2022.
- **Single Stock Dividend Futures:** Ordinary dividends with an ex-date on or before the Effective Date shall be multiplied by the Ratio for the purpose of determining the EDSP at the end of the lifetime of the **Jun22**, **Sep22** and **Dec22** maturities in contract AI8.

**Orders:**

All outstanding orders will be cancelled automatically after the end of the trading session on the day before the effective date. The priority of these orders will then be lost. New orders can be submitted as from the effective date.
