The equalisation payment amounts per series shall be communicated in an additional Corporate Action Notice to be issued on the effective date.
- **Exercise Prices:** The exercise prices have been multiplied by the Ratio, as shown in the attachment to this Notice.

Outstanding orders: All outstanding orders for contract AED will be cancelled automatically after the

end of the trading session of 14 October 2020. The priority of these orders will then be lost. New orders for **AED** can be submitted as from 15 October 2020.
