Options:

- **Lot Size:** 154 shares per lot, therefore the REN option class will be converted into the REN option class (lot size 100) and the O-class REO (lot size 54). The rounding difference will be neutralised by means of an equalisation payment, the equalisation amounts per series shall be communicated in an additional Corporate Action Notice.
- **Exercise Prices:** The exercise prices have been multiplied by the ratio, as shown in the Attachment to this Notice.

Futures:

- Given that there is no open interest, no adjustments have been made to the futures contract.
- **Single Stock Dividend Futures:** The ordinary dividend of €0.438 shall be multiplied by the Ratio, for the purpose of determining the EDSP at the end of the life time of the Dec15 maturity in RE8.

Further Series: No new series will be introduced in the O-class REO.
