### AEX Index® Futures Contract (FTI) – TRADING HOURS ON US HOLIDAYS

#### Executive Summary

This Notice informs Members that AEX Index® Future contract (FTI) will operate standard trading hours on US holidays in 2012.

**This Notice requires the attention of Members’ staff involved with the trading and settlement of NYSE Liffe products. Members should ensure that clients are made aware of the arrangements detailed in this Notice.**

#### 1. Introduction

1.1 This Notice informs Members that **AEX Index® Future Contract (FTI) will operate standard trading hours on US holidays during 2012.** This is a change from the arrangement in previous years, when the Contracts closed early on certain US holidays.

1.2 For the avoidance of doubt, this change affects the FTI trading hours on the following US holidays in 2012:

- Martin Luther King, Jr. Day (16 January 2012)
- Presidents’ Day (20 February 2012)
- Memorial Day (28 May 2012)
- Independence Day (4 July 2012)
- Labor Day (3 September 2012)
- Thanksgiving Day (22 November 2012)

1.3 The LIFFE CONNECT® standard session times for the Contracts will apply on these days, as follows:
