TRADING HOURS AND LISTED AEX-INDEX® DAILY AND WEEKLY OPTIONS DURING 24 DECEMBER 2012 TO 1 JANUARY 2013

Executive Summary

This Notice provides information regarding the trading arrangements for the period of 24 December 2012 to 1 January 2013 and shows the availability of AEX-index Daily and Weekly options during this period.

1. Summary of Trading Hours

- 1.1 The trading hours of the Amsterdam market during the period of 24 December 2012 to 1 January 2013 inclusive can be summarised as follows:

- All Individual Equity Option contracts will close at 13:55 hours CET
- All Option contracts on indices will close at 13:55 hours CET
- All Future contracts on indices will close at 14:00 hours CET
- All Currency products will close at 14:00 hours CET
- The Prof Transaction facility will close at 14:00 hours CET

Tuesday 25 December 2012 and Wednesday 26 December 2012

Market closed

Thursday 27 December 2012 and Friday 28 December 2012

Normal trading day for all Contracts.

- All Individual Equity Option contracts will close at 13:55 hours CET
- All Option contracts on indices will close at 13:55 hours CET
- All Future contracts on indices will close at 14:00 hours CET
- All Currency products will close at 14:00 hours CET
