Details: Brookfield Renewable Holdings entered into an exclusive negotiation with

several shareholders to acquire 53.32% of the outstanding shares of Neoen at a price of 39.85 euros per share. Following the completion of the block acquisition, Brookfield Renewable Holdings would become the majority shareholder in Neoen and would file a mandatory simplified cash tender offer for all of the remaining shares in Neoen at the same price per share as the

block acquisition of 39.85 euros per share ("the Offer").

**Adjustments:** Provided that the Offer becomes effective, the contracts shall be de-listed with immediate effect and will be settled using the Fair Value method. In

determining the Fair Value settlement prices, the following will apply:

#### **Options:**

- Fair Value Volatilities: For each individual series, Euronext will use the settlement volatility, which has been used for the calculation of the Daily Settlement Prices by Euronext Pricer, as shown in the Attachment to this Notice. In accordance with the Corporate Actions Policy, the Fair Value volatilities are determined from the Daily Settlement Prices of each respective contract series over the ten trading days preceding the announcement of the Offer, being the period from 16 May 2024 to 29 May 2024 inclusive.
- Dividends: The average dividend forecasts used for the calculation of daily Settlement Prices by Euronext Pricer, collected over a ten-trading day period (shown in the attachment to this notice).
- Interest Rates: Interest rates as used by Euronext Pricer on the effective date.
