	Ratio = (Cum Event Price - 4.75 pence - 4.00 pence) (Cum Event Price - 4.75 pence)		
	Futures:		
	<ul> <li>Variation Margin: Daily Settlement Prices of 22 May 2019 shall be multiplied by the Ratio to generate reference prices for the purpose of variation margin calculations at the close of business on 23 May 2019.</li> <li>New contract: In the event that the Ratio results in a lot size exceeding the standard lot size, a new contract will be introduced.</li> </ul>		

Single Stock Dividend Futures: Ordinary dividends with an ex-date on or before the Effective Date will be multiplied by the Ratio, for the purpose of determining the EDSP at the end of the life time of the Dec19 maturity in contract WM8.
