**Futures:**

- **Single Stock Futures:** For the purpose of the Variation Margin the Daily Settlement Prices for 16 November 2020 shall be multiplied by the Ratio to generate reference prices for the purpose of variation margin calculations, at the close of business on 17 November 2020.
- **Single Stock Dividend Futures:** As there is no open interest in the SSDF no further adjustments have been made.
