Details:

Alimentation Couche-Tard Inc. ("Couche-Tard") has submitted a non-binding offer to Carrefour SA ("Carrefour") for a friendly combination at a price of 20 EUR per Carrefour share (coupon attached). The terms of the transaction are under discussion, but the consideration is currently expected to be in cash in large majority ("the Offer").

Adjustments:

Provided that the consideration in cash is more than 67% of the total offer consideration and the Offer becomes effective, the contracts shall be de-listed with immediate effect and will be settled using the Fair Value method. In determining the Fair Value settlement prices, the following will apply:

Options:

- **Fair Value Volatilities:** For each individual series, Euronext will use the settlement volatility which has been used for the calculation of the Daily Settlement Prices by Euronext Pricer, as shown in the Attachment to this Notice. In accordance with the Corporate Actions Policy, the Fair Value volatilities are determined from the Daily Settlement Prices of each respective contract series over the ten trading days preceding the announcement of the Offer, being the period from 29 December 2020 to 12 January 2021 inclusive.
