Ratio Method

■ **Cum Event Price:** Official closing price of Rio Tinto Plc shares on LSE on 11 August 2021.

■ Lot Size: The lot size will be divided by the Ratio. The adjusted lot size will be specified in the Final Notice.

■ Ratio = (Cum Event Price - GBp 270.84 - GBp 133.26) (Cum Event Price - GBp 270.84)

## **Futures:**

- Variation Margin: Daily Settlement Prices for 11 August 2021 shall be multiplied by the Ratio to generate reference prices for the purpose of variation margin calculations at the close of business on 12 August 2021.
- **New contract:** In such case that the Ratio results in an adjusted lot size exceeding the standard lot size for contracts RV6 (100) and RV8 (10,000), new contracts (O-class) will be introduced. Contracts RV6 and RV8 will keep the standard lot size.
- Single Stock Dividend Futures: Ordinary dividends with an exdate on or before the Effective Date shall be multiplied by the Ratio for the purpose of determining the EDSP at the end of the lifetime of the Dec21 maturity in contract VV8.
