- **Exercise Prices:** The exercise prices will be multiplied by the Ratio. The adjusted exercise prices will be specified in the Final Notice.
- **Equalisation payment:** The rounding difference of the adjusted lot size will be neutralised by means of an equalisation payment.

- Single Stock Dividend Futures: Ordinary dividends with an exdate on or before the Effective date shall be multiplied by the Ratio, for the purpose of determining the EDSP at the end of the lifetime of the Sep21 and Dec21 maturity in contract VI8.

### Orders:

Orders are cancelled automatically after the end of the trading session of 16 September 2021. The priority of these orders will then be lost. New orders for VI1, VI3, VI6, VI7 and VI8 can be submitted as from 17 September 2021.
