- Variation Margin: Daily Settlement Prices of 4 May 2016 shall be multiplied by the ratio to generate reference prices for the purpose of variation margin calculations on 6 May 2016.
- Outstanding orders: All outstanding orders for FZ6 will be cancelled automatically
 after the end of the trading session on 4 May 2016. The priority of these orders
 will then be lost. New orders in FZ6 can be submitted as from 6 May 2016.
