0.72.

**Adjustments:** Provided that the Offer becomes effective, the contracts shall be de-listed with

immediate effect and will be settled using the Fair Value method. In determining the

Fair Value settlement prices, the following will apply:

# **Options:**

Euribor interest rates have been used in determining the implied volatilities.
- **Dividends:** The dividend payments which are shown in the Attachment to this Notice will be used in determining the Fair Value settlement prices.
- Interest Rates: Euribor interest rates shall be used in determining the Fair Value settlement prices.
- Further Series: Further series that are made available for trading, will be introduced in accordance with <u>Amsterdam Notice No. 07/027</u>.
