Adjustments **step 3:** Given that the Offer has become Effective, the following contract adjustments have been made:

- Ratio Method.
- The contracts have been re-designated as contracts based on Nokia shares trading on Euronext Paris. The contracts will be referred to by Euronext as NOKIA contracts.
- **Ratio:** 1.81818
- **Exercises:** Exercise instructions for contract CG1 are allowed as from 6 January 2016.

Options:

- **Lot Size:** The adjusted lot size is 55 shares per lot for contracts CG1 (**Jun16 and Dec16 will have an adjusted lot size of 58**) and the adjusted lot size is 6 shares per lot for contracts CG3, as shown in the attachment to this notice. The rounding difference will be neutralized by means of an equalisation payment, to be specified in an additional Corporate Action Notice. Given that there is no open interest, no other adjustments have been made to contract CG7.
- **Exercise prices:** The exercise prices have been multiplied by the ratio, as shown in the Attachment to this notice.

Futures:

- Given that there is no open interest, no other adjustments have been made to futures contract LC6.
