TRADING ARRANGEMENTS FROM 14 MARCH 2011 TO 25 MARCH 2011 INCLUSIVE**AEX[®] FUTURE CONTRACT (FTI)****Executive Summary**

This Notice informs members of changes to trading arrangements for the AEX[®] Future Contract between 14 March 2011 and 27 March 2011 inclusive.

1. Introduction

- 1.1 Members will be aware that Daylight Saving Time (“DST”) in the United States commences on 13 March 2011 and ends on 6 November 2011, whereas Central European Summer Time (“CEST”) do not begin until 27 March 2011 and end on 30 October 2011. This Notice informs members of changes to the trading arrangements for certain Exchange Contracts as a result of these differences.

2. AEX[®] Index Futures Contract

- 2.1 For the period of Monday 14 March 2011 to Friday 25 March 2011 inclusive, the Exchange has determined to amend the trading hours for AEX[®] Index Futures Contract and for the BEL20[®] Future Contract such that these Contracts shall close at 21:00 hours (Amsterdam time).
- 2.2 Daily settlement prices for AEX[®] Index Futures Contract and the BEL20[®] Future Contract shall continue to be established at the usual time. Full details of the LIFFE CONNECT[®] session times for this Contract during the relevant period are contained in the Attachment to this Notice.

3. Normal Session Times

- 3.1 The Contract shall revert to its normal session times on and from Monday 28 March 2011.
