### FINANCIAL DERIVATIVES LARGE IN SCALE TRADING HOURS

#### Executive Summary

This Notice informs Members about an update to the trading hours for the Large-in-Scale Facility on the Euronext Financial Derivatives products.

1. Euronext will extend the Large-in-Scale Facility trading hours for some its financial derivatives contracts.
2. Pursuant to the Trading Procedure 4.5.5, Euronext would like to inform Members that as from Monday, the 01 February, 2016, trading hours on certain contracts will be extended on the Large-in-Scale Facility comprising former Block Trade and Prof Transactions . The main changes are summarised below:
  - AEX and CAC Index Futures (including Weekly and Mini) remain open until 22:00 CET;
  - FTSE EPRA/ NAREIT Developed Europe, FTSE EPRA/NAREIT Eurozone, FTSEurofirst80 and FTSEurofirst100 Index Futures until 20:00 CET;
  - All other contracts until 18:30 CET.

An earlier opening of 7:00 CET will also be initiated for all contracts, whereas previously this was only available on certain contracts.

3. Pursuant to the Trading Procedure 4.5.6, Euronext informs Members that on the Last Trading Day, the Large-in-Scale Facility is available between 7:00 and 18:30 CET for all expiring contracts. All non-expiring contracts follow the normal trading hours. Both opening and closing times on expiry are new for those contracts that used to benefit from Block trades.
4. All trades submitted via the Large-in-Scale Facility after 18:30 CET on the expiry contract, will not be accepted.
